## **Rickley Park Primary School Policy for the use of the CCTV system (June 2014)**

### **1. Key Value**

We look after ourselves, each other and our world by taking responsibility for our actions.

### **2. Introduction**

2.1 Rickley Park Primary School uses closed circuit television (CCTV) images to reduce crime and monitor the school buildings in order to provide a safe and secure environment for pupils, staff and visitors, and to prevent the loss or damage to school property.

The school's governing body is the data controller. In this role it is legally responsible for the school's data protection requirements, and for the school's CCTV system.

2.2 The system comprises of a number of fixed and dome cameras

2.3 The system does not have sound recording capability.

2.4 The CCTV system is owned and operated by the school and its deployment is determined by the school's leadership team.

2.5 The CCTV is monitored centrally from the main reception desk and the communications room (*off of the school library*). Currently the site manager is the member of staff trained to use the equipment fully, although the administration team are able to use the equipment to monitor movements.

2.6 The introduction of, or changes to, CCTV monitoring will be subject to consultation with staff and the school community.

2.7 The school's CCTV Scheme is registered with the Information Commissioner under the terms of the Data Protection Act 1998 (*see Appendix C*). The use of CCTV, and the associated images and any sound recordings, is covered by the Data Protection Act 1998. This policy outlines the school's use of CCTV and how it complies with the Act.

2.8 All authorised operators and employees with access to images are aware of the procedures that need to be followed when accessing the recorded images and sound. All operators are trained by the school data controller in their responsibilities under the CCTV Code of Practice. All employees are aware of the restrictions in relation to access to, and disclosure of, recorded images and sound.

### **3. Statement of Intent**

3.1 The system is intended to provide and promote a safe secure environment for pupils and for those who work or use the facilities of the school; and to protect the school buildings and resources. It is hoped that it will also reduce the fear of crime and anti-social behaviour within the location. The system is intended to view and monitor activity in the immediate area of the school only.

3.2 It shall be used for the purposes of:

- pupil, staff and public safety;
- protection of our premises;
- preventing and deterring crime & antisocial behaviour; and
- assisting responsible agencies in the investigation of crime & antisocial behaviour.

It will achieve this by:

- providing evidential quality images of criminal incidents and suspects; and
- assisting the responsible authorities in the investigation of crime & disorder.

3.3 The school complies with Information Commissioner's Office (ICO) CCTV Code of Practice to ensure it is used responsibly and safeguards both trust and confidence in its continued use. The Code of Practice is published at:

2.4 CCTV warning signs are clearly and prominently placed at all external entrances to the school, including school gates. Signs contain details of the purpose for using CCTV (see *appendix B*). In areas where CCTV is used, the school ensures that there are prominent signs placed at both the entrance of the CCTV zone and within the controlled area.

2.5 The planning and design has endeavoured to ensure that the Scheme will give maximum effectiveness and efficiency but it is not possible to guarantee that the system will cover or detect every single incident taking place in the areas of coverage.

### **3. Siting the Cameras**

3.1 Cameras are sited so that they only capture images relevant to the purposes for which they are installed (see 2.2) and care will be taken to ensure that reasonable privacy expectations are not violated. The School will ensure that the location of equipment is carefully considered to ensure that images captured comply with the Data Protection Act.

3.2 The school has made every effort to position cameras so that their coverage is restricted to the school premises, which may include outdoor areas.

3.3 CCTV is not used in classrooms.

3.4 Members of staff have access to details of where CCTV cameras are situated (see *Appendix D*), with the exception of cameras placed for the purpose of covert monitoring.

### **4. Covert Monitoring**

4.1 The school may in exceptional circumstances set up covert monitoring. For example:

- i) Where there is good cause to suspect that an illegal or unauthorised action(s), is taking place, or where there are grounds to suspect serious misconduct; or
- ii) Where notifying the individuals about the monitoring would seriously prejudice the reason for making the recording.

4.2 In these circumstances authorisation must be obtained from a member of the senior management team.

- 4.3 Covert monitoring must cease following completion of an investigation.
- 4.4 Cameras sited for the purpose of covert monitoring will not be used in areas which are reasonably expected to be private, for example toilets.

#### **5. Storage and Retention of CCTV images**

- 5.1 Recorded data will not be retained for longer than is necessary. While retained, the integrity of the recordings will be maintained to ensure their evidential value and to protect the rights of the people whose images have been recorded.
- 5.2 All retained data will be stored securely.

#### **6. Access to CCTV images**

- 6.1 Access to recorded images will be restricted to those staff authorised to view them, and will not be made more widely available.

#### **7. Subject Access Requests (SAR)**

- 7.1 Individuals have the right to request access to CCTV footage relating to themselves under the Data Protection Act.
- 7.2 All requests should be made in writing to the Headteacher. Individuals submitting requests for access will be asked to provide sufficient information to enable the footage relating to them to be identified. For example, date, time and location.
- 7.3 The school will respond to requests within 40 calendar days of receiving the written request and fee.
- 7.4 A fee of £10 will be charged per request.
- 7.5 The school reserves the right to refuse access to CCTV footage where this would prejudice the legal rights of other individuals or jeopardise an ongoing investigation.

#### **8. Access to and Disclosure of Images to Third Parties**

- 8.1 There will be no disclosure of recorded data to third parties other than to authorised personnel such as the Police and service providers to the school where these would reasonably need access to the data (e.g. investigators).
- 8.2 Requests should be made in writing to the Headteacher.
- 8.3 The data may be used within the school's discipline and grievance procedures as required, and will be subject to the usual confidentiality requirements of those procedures.

#### **9. Complaints**

- 9.1 Complaints and enquiries about the operation of CCTV within the school should be directed to the Headteacher in the first instance.

## Appendix A - Checklist

This CCTV system and the images produced by it are controlled by the headteacher who is responsible for how the system is used and for notifying the Information Commissioner about the CCTV system and its purpose (*which is a legal requirement of the Data Protection Act 1998*).

Rickley Park Primary School has considered the need for using CCTV and decided it is required for protecting the safety of pupils, staff, the wider school community and our premises and for the prevention and detection of crime. It will not be used for other purposes. We conduct an annual review of our use of CCTV.

Notification has been submitted to the Information Commissioner and the next renewal date recorded.			
There is a named individual who is responsible for the operation of the system.			
A system had been chosen which produces clear images which the law enforcement bodies (usually the police) can use to investigate crime and these can easily be taken from the system when required.			
Staff and members of the school community will be consulted about the proposal to install CCTV equipment.			
Cameras have been sited so that they provide clear images.			
Cameras have been positioned to avoid capturing the images of persons not visiting the premises.			
There are visible signs showing that CCTV is in operation. Where it is not obvious who is responsible for the system contact details are displayed on the sign(s).			
Images from this CCTV system are securely stored, where only a limited number of authorised persons may have access to them.			
The recorded images will only be retained long enough for any incident to come to light (e.g. for a theft to be noticed) and the incident to be investigated.			
Except for law enforcement bodies, images will not be provided to third parties.			
The organisation knows how to respond to individuals making requests for copies of their own images. If unsure the controller knows to seek advice from the Information Commissioner as soon as such a request is made.			
Regular checks are carried out to ensure that the system is working properly and produces high quality images.			

## **Appendix B – CCTV Signage**

It is a requirement of the Data Protection Act 1998 to notify people entering a CCTV protected area that the area is monitored by CCTV and that pictures are recorded. The school is to ensure that this requirement is fulfilled.

**The CCTV sign should include the following:**

- That the area is covered by CCTV surveillance and pictures are recorded
- The purpose of using CCTV
- The name of the school
- The contact telephone number or address for enquiries



## **Appendix C – Data Protection Act**

### **The Data Protection Act 1998: Data Protection Principles**

1. Personal data shall be processed fairly and lawfully and, in particular, shall not be processed unless:
  - (a) at least one of the conditions in Schedule 2 is met, and
  - (b) in the case of sensitive personal data, at least one of the conditions in Schedule 3 is also met.
2. Personal data shall be obtained only for one or more specified and lawful purposes, and shall not be further processed in any manner incompatible with that purpose or those purposes.
3. Personal data shall be adequate, relevant and not excessive in relation to the purpose or purposes for which they are processed.
4. Personal data shall be accurate and, where necessary, kept up to date.
5. Personal data processed for any purpose or purposes shall not be kept for longer than is necessary for that purpose or those purposes.
6. Personal data shall be processed in accordance with the rights of data subjects under this Act.
7. Appropriate technical and organisational measures shall be taken against unauthorised or unlawful processing of personal data and against accidental loss or destruction of, or damage to, personal data.
8. Personal data shall not be transferred to a country or territory outside the European Economic Area unless that country or territory ensures an adequate level of protection for the rights and freedoms of data subjects in relation to the processing of personal data.

## Appendix D – Location of CCTV Cameras

Camera Number	Location	Fixed or Dome?
1	In the outer entrance foyer (Camera positioned above the controlled door)	Fixed
2	In the inner entrance foyer (Camera positioned above the bursar office door)	Fixed
3	In the outer entrance foyer (Camera positioned to look across foyer and see office opening)	Fixed
4	In the reception classroom (Camera positioned to look at the main cloakroom door)	Fixed
5	In the Upper Playground (Camera positioned on a post by the path down to the Astroturf)	Dome
6	In the Lower Playground (Camera positioned on a post by the bike sheds)	Dome
7	Main roundabout and vehicle access (Camera positioned on a post by the bike sheds)	Fixed
8	In KS1 corridor (Camera positioned outside Music Room looking down to Y2 cloakroom)	Fixed
9	By staff car park door entrance (Camera positioned inside door looking inwards)	Fixed
